

2026 Meet & Greet Ride Waiver Instructions

IMPORTANT – Please Read Before Attending

To participate in the 2026 Meet & Greet Ride, every participant must complete the required liability waivers. Please review the instructions below carefully.

1. Required Waivers

You agreed during registration to complete any additional waivers required for participation.

There are **Three** waivers included:

- **Hollerwood Park Liability Waiver**
- **Meet & Greet Ride Supplemental Event Waiver**
- **First Frontier Appalachian Trails**

2. Who Must Sign?

Every person riding in your vehicle must sign **both** waivers, including:

- Adults
- Minors (parent/legal guardian signature required where applicable)

3. Signature Pages

The signature pages for all 3 waivers together make up **one complete waiver packet** for each participant.

These waivers are valid **only for the dates of the 2026 Meet & Greet Ride**.

4. Waiver with Red Lettering at top

On the the Supplemental Event Waiver (look for the **red lettering at the top**), under "**Duties,**" simply write "participant".

Do not complete the witness section at the bottom of this waiver. Event staff will complete that portion during check-in.

5. Bring Your Waivers

Please print the completed signature pages only and bring them with you to check-in at the event.

Having your waivers completed before you arrive will help speed up the check-in process and get you on the trails faster.

RIDER'S RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISK

BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE

RIGHT TO SUE - PLEASE READ CAREFULLY

In consideration for the opportunity for event participation and utilization of the riding park,

recreational facilities, trails, or other restricted areas of Hollerwood Park, and their respective affiliates, owners, employees or agents in furtherance of any sport involving a motor vehicle propelled by power, other than muscular power, including, but not limited to, dirt bike riding, motor sports racing, motor sports, and recreational or competitive activities, (hereinafter collectively called "Motor Sports" or "Riding Activity"):

I hereby understand and agree to this RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND

ASSUMPTION OF RISK and to the terms hereof as follows:

1. I, the undersigned, understand that Motor Sports is an action sport and recreational activity involving travel in three dimensions and that such activity is subject to accidents, injury and even death of participants. I understand that I may suffer broken bones, internal injuries, paralysis, or fatal injury, as well as the loss of or damage to personal property while participating in Motor Sports.
2. I, the undersigned, hereby RELEASE AND DISCHARGE Hollerwood Park, and all related parties, company officers, directors, elected officials, agents, employees, event volunteers, racing associations, participants, inspectors, surveyors, consultants, sponsors, facility operators, owners of

equipment, and owners of the land used for outdoor recreation from ANY and ALL LIABILITY, claims, demands, loss or damage, or causes of action that I, my personal representatives, heirs, next of kin, or assigns may hereafter have for injuries, loss of life, damage to, or loss of, property, and all other forms of damages arising out of my participation in Motor Sports, included, but not limited to, losses, injuries to the person or property, or death of the undersigned CAUSED BY OR ARISING OUT OF THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE.

3. I, the undersigned, understand and acknowledge that Motor Sports have inherent dangers that no amount of care, caution, instruction, inspection, or expertise can eliminate and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY OR OTHER FORMS OF DAMAGES SUSTAINED WHILE PARTICIPATING IN MOTOR SPORTS WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE.

4. I, the undersigned, understand and acknowledge that Motor Sports have inherent dangers with respect to operating equipment on real property and land that may have both obvious and/or hidden dangers whether natural or man-made, including, but not limited to, trees, tree limbs, fence posts, snow, ice, earth, wildlife, variations in surface, streams, creeks, cliffs, crevasses, stumps, hills, pot holes, rocks, brush and other debris and that no amount of care, caution, instruction, inspection or expertise can eliminate such obvious and/or hidden dangers. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY OR OTHER FORMS OF DAMAGES SUSTAINED WHILE PARTICIPATING IN MOTOR SPORTS THAT MAY BE CAUSED BY SUCH RISK, HAZARDS AND OBVIOUS AND/OR HIDDEN DANGERS WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE.

5. I, the undersigned, agree that I, my estate, or any other representative WILL NOT SUE OR OTHERWISE MAKE A CLAIM AGAINST THE RELEASED PARTIES for damages or other losses sustained as a result of my participation in the aforementioned Motor Sports.

6. I, the undersigned, hereby agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorney's fees, incurred in connection with any action brought against them, jointly or severally, as a result of my participation in Motor Sports.

7. I, the undersigned, will take full responsibility for, and hold harmless the RELEASED PARTIES for any injury, property damage, or death that I may suffer or inflict upon others or their property as a result of my engaging in Motor Sports.

8. I, the undersigned, agree that I will operate all equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual.

9. I, the undersigned, represent that this RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISK shall continue in full force and effect for so long as I engage in Motor Sports which are in way connected to or with the RELEASED PARTIES.

10. I, the undersigned, represent that I am at least eighteen (18) years of age. I further acknowledge that the RELEASED PARTIES are relying on the participant's affirming that he/she is not a minor child.

11. I, the undersigned, expressly recognize that this RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISK is a contract pursuant to which I have released any and all claims against the RELEASED PARTIES resulting from participation in Motor Sports including any claims related to the negligence of the RELEASED PARTIES or otherwise.

12. I, the undersigned, acknowledge that the activities associated with Motor Sports are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the RELEASED PARTIES. I acknowledge that this agreement extends to all acts of negligence by the RELEASED PARTIES, including negligent rescue operations.

13. Photo and Production Rights: I, undersigned, either adult or parent/guardian of minor agree that all rights, property, and interest in any photograph, broadcast by radio, television, motion pictures, home video productions or by any other means or media (including any transcriptions of any such broadcast) of any Riding Activities, as well as any and all receipts there-from, belong to Hollerwood Park for its exclusive and unlimited use. I further agree that Hollerwood Park or its assigns, on a non-exclusive basis, may use my name and pictures (including pictures of my racing equipment and pictures taken during Riding Activities) for any purpose and in any media including, but not limited to, television, motion pictures, advertising, trade, home video production or any lawful purpose, and I waive any right to inspect or proof the finished version. I also understand that Hollerwood Park may, from time to time, engage a sports marketing firm to, among other things, promote the image of the Riding Activities, and I agree to cooperate with Hollerwood Park and its sports marketing firm in such efforts.

14. This release and waiver is intended to be as broad and inclusive as permitted by the laws of the United States of America and the State of Kentucky and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This agreement shall be continuing and shall apply to the use of the property and facilities by me on any future date. This waiver reflects the entire understanding of this agreement, and no statements, promises or inducements not contained in this agreement shall be valid or binding.

15. I, the undersigned, have read and understand the above and acknowledge that the same constitutes a release of liability and waiver of my legal rights and I also acknowledge that I am assuming all liability stemming from the inherent, known, and obvious risks arising out of my engaging in Motor Sports.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

DESCRIPTION AND LOCATION OF SCHEDULED EVENT(S)

IN CONSIDERATION of being permitted to compete, officiate, observe, work, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering any of such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which he/she enters, and he/she further agrees and warrants that, if at any time, he/she is in or about RESTRICTED AREAS and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and if necessary will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S).
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, sponsors, advertisers, owners and leasees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents, employees, representatives, owners, members, affiliates, successors and assigns all for the purposes herein referred to as "Releasees," FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the UNDERSIGNED'S INJURY OR DEATH, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASEES or otherwise.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED, also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State or Province in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

First Frontier Appalachian Trails - Waiver and Release of Liability (Please sign at the bottom, the Fall Meet and Greet ride ticket includes all permits, this is just the legal waiver we are required to have you read and sign off on)

PLEASE READ CAREFULLY BEFORE PURCHASING A PERMIT OR ENTERING THE FIRST FRONTIER APPALACHIAN TRAILS SYSTEM. COMPLETING THIS PURCHASE SIGNIFIES AGREEMENT WITH THIS WAIVER AND RELEASE OF LIABILITY. THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS.

Please review the following Agreement. You have voluntarily elected to participate, and if applicable, to allow your minor child(ren) and all minor children under your supervision and referred to individually and collectively herein as “child” to participate in activities sponsored by First Frontier Appalachian Trails being ridden on privately owned property leased by First Frontier Appalachian Trails. In consideration of being allowed to participate in these activities and any other services provided by the First Frontier Appalachian Trails or its agents, you represent, acknowledge and agree as follows:

I. General Release: You hereby acknowledge and agree that this Agreement covers and is intended to release and provide benefits, legal protections and consideration to First Frontier Appalachian Trails their agents, land owners, officers, affiliates, participants, employees, and all other persons or entities acting in any capacity on its behalf.

II. Release of Potential Injuries: You hereby acknowledge and agree that the use of all-terrain vehicles (“ATVs”) and that participating in the use of ATVs and other activities related thereto is inherently and obviously dangerous. The risks include serious physical or emotional injury, death, paralysis, damage to yourself, child, and/or third parties, and damage to personal property of any or all such persons. You hereby acknowledge and agree that such risks simply cannot be eliminated without jeopardizing the essential qualities of riding ATVs, which you further agree is for recreational purposes and completely voluntary. You acknowledge and agree that while riding ATVs and other related activities that

take place on the Trail are periodically monitored by emergency personnel, it is not feasible for such personnel to monitor the activities and actions of all participants simultaneously at all locations. All such activities, actions and risks inherent in the use of ATVs are included, without limitation, in the Release of Liability in Paragraph V herein.

III. Voluntary Assumption of Risks: You hereby further acknowledge and agree that you, and a child, if applicable, are participating voluntarily and at their own risk. In addition, you acknowledge and agree that the actions or activities of other participants or the actions or inactions of the releasees all sponsors and landowners, board members, etc., could cause you or the child significant bodily injury and that releasees are not responsible for the actions or activities of participants using the Trail or the negligence in supervising the Trail or its usage, including actions, activities, or omissions that result in such harm. Some of the risks include, but are not limited to, the following:

1. Death, paralysis, partially or fully, through use of the Trail and participation in ATV activities.
2. Open wounds, bumps, bruises, the transmission of disease strains and allergic reactions through the use of the Trail or contact with other participants or surfaces they have contacted. Participants may sprain, pull, break or otherwise seriously externally or internally injure their head, face, neck, torso, spine, arms, wrists, hands, legs, ankles, feet or any other body parts as a result of falling off the ATV or other equipment, landing improperly on the ATV or other equipment or making contact with other participants. As noted in paragraph 1 above, such injury can lead to death, paralysis or disfigurement. Participation could further result in heat stroke, heart attack, dehydration or other exertion related medical events.
3. Observing, standing, walking, sitting or taking photographs at or near the Trail can result in similar physical injury even if the observer is not him or herself participating at the time.
4. Potential encounters with snakes, spiders, and wild animals as well as exposure to waterborne diseases.

IV: Agreement to pay my own medical expenses: You acknowledge, accept, and assume the risk of any and all medical conditions, limitations, or disabilities (whether temporary or permanent) that you or the child possess, whether known or unknown, which might contribute to or exacerbate an injury you or the child might sustain as the result of using the Trail. You acknowledge and agree that if medical assistance of any form, including emergency care, hospitalization, outpatient care, and/or physical therapy, is required or performed as a result of any injury you or the child sustains while using the Trail, such assistance shall be at your own expense.

V: Release of Liability: The Releasing Parties (as defined below) hereby forever, irrevocably and unconditionally release, waive, relinquish, discharge from liability and covenant not to sue First Frontier Appalachian Trails; and/or their agents, owners, officers, affiliates, participants, employees, and all other persons or entities acting in any capacity on its behalf or other private property owners granting permission to cross their property on a trail (collectively "Releasees") from any and all claims, demands, rights, actions, suits, causes of actions, obligations, debts, costs, losses, charges, expenses, attorneys' fees, damages, judgments and liabilities, of whatever kind or nature, in law, equity or otherwise, whether known or unknown, suspected or unsuspected, and whether or not concealed or hidden, related to or arising directly or indirectly from you or the child's access to and/or use of the Trail, the child's and/or your entry into the Trail, the condition, maintenance, inspection, supervision, control or security of the Trail, the failure to warn of dangerous conditions in connection with the Trail, and/or the acts or omissions of any of the Releasees, including, without limitation, any claim for negligence, failure to warn or other omission, property damage, personal injury, emotional

injury, illness, bodily harm, paralysis or death. You understand that this release and waiver applies not only to use of the ATVs and related equipment but also all activities at the Event. You understand that this Release and Waiver applies to and includes all activities that you or the child engage in at the Event. In the event that any claim released herein is brought by, or asserted on behalf, the Releasing Parties, you shall immediately defend, indemnify and hold harmless the Releasees, and any of them, from any loss or liability, including reasonable attorneys' fees, associated therewith or arising therefrom.

VI: Term of Agreement: You understand that this Agreement extends forever into the future and will have full force and effect each and every time you or the child participate in any event sponsored by First Frontier Appalachian Trails or any other private individual granting permission for their property to be crossed by the trail.

VII: Responsibility: You and each child agree to follow the following code of participant responsibility:

1. You acknowledge and agree there are inherent risks in the participation in or on the Trail, and that such risks include not only use of ATVs, but other activities and equipment. Participants of the Event who use the ATVs, and those who engage in any other activities or use of any other equipment, by participation, accept the risks inherent in such a participation of which the ordinary prudent person is or should be aware. Participants have a duty to exercise good judgment and act in a responsible manner while using the Trail and other equipment, and while engaging in such activities. Participants have a duty to obey all oral or written warnings, or both, prior to or during participating, or both.
2. You acknowledge and agree that you have a duty not to participate in any activity on the Trail or engage in any other activity or use of any other equipment, when under the influence of drugs or alcohol.
3. You acknowledge and agree that you have a duty to properly use all necessary safety equipment while on the Trail.
4. You acknowledge and agree that you have a duty not to participate in any activity at the Trail or engage in other activities or use of other equipment, if you have a pre-existing medical condition or if you may be pregnant.
5. You acknowledge and agree that you have a duty to remove inappropriate attire, accessories, or dangerous objects prior to entering the Trail.
6. You acknowledge and agree that you have a duty to avoid bodily contact with other participants.
7. You acknowledge and agree that you have a duty to conform to meet the height, weight or age restrictions imposed by the manufacturer or owner to use and participate in any ATV riding.
8. You acknowledge and agree that you have a duty to use the Trail and other equipment within my own limitations, training and acquired skills.

9. You acknowledge and agree that you have a duty to avoid landing on head or neck as serious injuries, paralysis or death can occur.

10. You agree to explain all safety rules to each child you accompany, and to ensure that each child obeys the safety rules.

11. You have had sufficient opportunity to read this document. You have read and understood and agree to be bound by its terms. You understand that the no releasee has the authority to waive any provision of this Agreement. This Agreement constitutes and contains the entire agreement between Releasees and you relating to the child's and your use of the Trail. There are no other agreements, oral, written, or implied, with respect to such matters. You agree that if any portion of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force.

12. By purchasing a permit, you represent and warrant that if this waiver pertains to your minor child that you are the parent, legal guardian, or power of attorney for the child and have the authority to execute this Agreement on his or her behalf and to act on his or her behalf. You have read each and every paragraph of this Agreement and you agree to be bound by the terms states herein, including the release of liability contained herein. You further agree to indemnify and hold harmless the Releasees from any and all claims which are brought by or on behalf of the child, which is in any way connected with, arising out of, or result from such child's use of the Trail. You are eighteen (18) years of age or older. You are entering into this Agreement on behalf of yourself, your spouse or domestic partner, the child, and our respective and/or collective issue, parents, siblings, heirs, assigns, personal representatives, estates, and anyone else who may claim by or through such person or persons ("the Releasing Parties").

BY PURCHASING A PERMIT, YOU ACKNOWLEDGE AND AGREE THAT IF YOU OR ANY OF YOUR CHILDREN ARE INJURED IN ANY WAY, THIS WAIVER PREVENTS AND PROHIBITS ANY RECOVERY OF MONEY FROM FIRST FRONTIER APPALACHIAN TRAILS; THEIR AGENTS, OWNERS, OFFICERS, AFFILIATES, PARTICIPANTS, EMPLOYEES, AND ALL OTHER PERSONS OR ENTITIES ACTING IN ANY CAPACITY ON ITS BEHALF (COLLECTIVELY OR ANY PRIVATE INDIVIDUAL GIVING PERMISSION FOR PARTICIPANTS TO CROSS THEIR PROPERTY ON A TRAIL "RELEASES").
